I confirm to the best of my knowledge and belief, having made appropriate enquiries of other Chief Officers of Gedling Borough Council, the following representations given to you in connection with your audit of the Council's financial statements for the year ended 31.03.06.

I acknowledge my responsibility under the relevant statutory authorities for preparing the financial statements that present fairly and for making accurate representations to you.

I confirm that I believe that there are no misstatements, however, we have changed some main accounting systems part way through the financial year. This has resulted in some difficulties in reconciliation of amounts between the new and old systems. Where full reconciliation were not possible, estimation techniques have been applied. Where this is the case best professional judgement has been used and I am satisfied that there are no material mis-statements as a result.

The Council has no plans or intentions that may materially alter the carrying value or classification of assets and liabilities reflected in the financial statements.

Specific Representations

There are no other material amounts relating to unfunded liabilities, curtailments or settlements of past service costs relating to pension provision other than those which have been properly recorded and disclosed in the financial statements.

Supporting Records

All the accounting records have been made available to you for the purpose of your audit and all the transactions undertaken by the Council have been properly reflected and recorded in the accounting records. All other records and related information, including minutes of all Council and Cabinet meetings, have been made available to you.
