At its meeting on 1 June, Cabinet considered a report updating the Strategic Corporate Plan, incorporating the Best Value Performance Plan (minute 3 refers).

The report included results against statutory and local performance indicators for 2005/06, and targets for these measures for 2008/09 and, in some cases, new and amended targets for the intervening years.

The Head of Finance reported that results for a small number of indicators were still awaited at the time, but that these outstanding details would be available before this Council meeting.

Details for those indicators have now been received and are set out in the table below. Almost all were new indicators in April 2005, which explains why actual and target figures for 2004/05 and 2005/06 respectively are not available.
