Poet's Corner, Newstead Abbey Park.

Erection of domestic wind turning on 15 metre high mast with 9 metre diameter rotor blade.

RESOLVED to refuse planning permission for the following reason:-

In the opinion of the Borough Council the proposed development would have an adverse impact on the character and significance and historic value of the landscape of Newstead Abbey Park which is designated as Grade II*on the Register of Parks and Gardens. In line with paragraph 133 of the National Planning Policy Framework, the Borough Council has given consideration as to whether the proposed development will result in harm to or loss of significance of a designated heritage asset. In this instance, the Borough Council considers that the proposal would result in less than substantial harm to the heritage asset but the harm to the asset would be not outweighed by any public benefits of the proposal. The proposal would therefore be contrary to paragraph 133 of the National Planning Policy Framework (March 2012) and Policy ENV25 of the Gedling Borough Council Replacement Local Plan (Certain Policies Saved) 2008.
