## Subject: Appointments to Scrutiny Committee, Standing Ordinary Committees and Sub-Committees of the Council. <br> Date: 22 May 2013

1. Purpose of the Report

To make appointments to the committees of the Council for the 2013-14 municipal year.

## 2. Background

In determining the membership of committees, account must be taken of the requirements of the Local Government (Committees and Political Groups) Regulations 1990 and 1991 made under sections 15 and 16 of the Local Government and Housing Act 1989. These regulations require that seats on committees and sub-committees are allocated to the political groups in a way which reflects the overall political balance of the Council.

Following the Kingswell ward by election, held on 2 May 2013, the political make-up of the Council remains:

Labour 31
Conservative 15
Liberal Democrat 4
The majority group have given notice of their intention to disestablish both the Policy Review Scrutiny and Performance Review Scrutiny Committees, leaving a strengthened Overview and Scrutiny Committee to fulfil the scrutiny function. The Overview and Scrutiny Committee will consist of 13 members, appointed on a basis proportionate to party membership on the Council.

There will therefore be a total of 89 committee seats to be allocated for the 2013/14 municipal year. The allocation of seats on the committees and subcommittees of the Council is, therefore, as follows:
