Subject: Notices Served- Public Protection

Environmental Protection Act 1990 Section 80

1. A Notice was served on the occupier of a property on Dale Road, Carlton on 9th May 2012 to clear away accumulations of household waste from the land and maintain the area in such condition as not to cause a subsequent statutory nuisance. The rubbish was cleared and monitoring is ongoing to ensure compliance is maintained.
2. Two Notices were served on the occupier of a property on Deabill Street, Netherfield on 18th May 2012 to clear away an accumulation of waste stored in the front bedroom and to abate the nuisance caused by the render brickwork and guttering at the front of the property. The Notices have not yet expired.
3. A Notice was served on the occupier of a property on The Green, Carlton on 28th May 2012 to silence the intruder alarm and repair any defect before resetting. The notice was complied with.
4. A Notice was served on the owner of a property on Westdale Lane West, Mapperley, on 1st June 2012 to clear away an accumulation of household waste from the area to the rear of the property. The notice was complied with.
5. A Notice was served on the occupier of a property on Shorwell Road, Carlton on 17th May 2012 to clear away an accumulation of household waste from the land and maintain the land in such a condition as not to cause a statutory nuisance. The notice was complied with.
6. A Notice was served on the occupier of a property on Woodland Grove, Colwick on 3rd July 2012 to clear away an accumulation of household waste from the area to the rear of the property. The Notice has not yet expired.
7. A Notice was served on the occupier of a property on Dale Road, Carlton, on 31st May 2012 to cease the playing of loud music at such volume as to cause a statutory noise nuisance. The notice was breached and officers were

concerned about the impact of further breaches on the community. A warrant was obtained and the noise making equipment was seized.

FOOD HYGIENE (ENGLAND) REGULATIONS 2006 Section 6

A Notice was served on the owner of a property on Woodborough Road, Mapperley on 17th May 2012 to keep the property clean and maintaining good repair and condition. This is currently being monitored.

Environmental Protection Act 1990 sections 87 and 88

Under the above legislation it is an offence if any person throws down, drops or otherwise deposits litter on any public land. The Act also enables the local Authority to operate a fixed penalty scheme whereby the offender may be given the option for paying a fixed penalty within 14 days and so discharge any liability of conviction for that offence by the Court. The current level of fixed penalty is £50.00.
