COMMITTEE REPORT OCTOBER 2012

Environmental Protection Act 1990 Section 80

A Notice was served on the Contractors at the development site on Oakdale Road, Carlton on 16th August 2012 to prevent the occurrence of a statutory nuisance from smoke and smells as a result of burning any materials on the site. The Notice was complied with.

Housing Act 2004 Section 20

Two Orders were served on the owner of the property on St Michaels Avenue, Gedling, on 26th September 2012 to improve the housing conditions of the property, in relation to fire safety measures. The period for compliance has not yet expired.

An Order was served on the owner of the property on First Avenue, Carlton Hill on 12th October 2012 to prohibit the use of an unauthorised loft conversion. The period for compliance has not yet expired.

FOOD HYGIENE (ENGLAND) REGULATIONS 2006 Section 6

A Notice was served on the Food Business Operator for a business on Carlton Square, Carlton on 16th August 2012 to keep the property clean and maintaining good repair and condition. This is currently being monitored.

A Notice was served on the Food Business Operator for a business on Main Road, Gedling on 23rd August 2012 to keep the property clean and maintaining good repair and condition. This is currently being monitored.

A Notice was served on the Food Business Operator for a business on Main Road, Gedling on 23rd August 2012 to establish and maintain suitable documents and records to demonstrate the effective application of identification of potential food hazards. This is currently being monitored.

Two Notices were served on the Food Business Operator for a business on Victoria Road, Netherfield, on 18th September 2012 to keep the property clean and maintaining good repair and condition. This is currently being monitored.

Two Notices were served on the Food Business Operator for a business on Main Road Burton Joyce, on 26th September 2012 to keep the property clean and maintaining good repair and condition. This is currently being monitored.

Environmental Protection Act 1990 sections 87 and 88

Under the above legislation it is an offence if any person throws down, drops or otherwise deposits litter on any public land. The Act also enables the local Authority to operate a fixed penalty scheme whereby the offender may be given the option for paying a fixed penalty within 14 days and so discharge any liability of conviction for that offence by the Court. The current level of fixed penalty is £50.00.
