### **COMMITTEE REPORT MARCH 2013**

### Environmental Protection Act 1990 Section 80

A Notice was served on the occupier of a property on Park Road, Bestwood on 4<sup>th</sup> January 2013 to prevent the accumulation of domestic refuse and furnishings at the rear of the property. This notice was not complied with and officers arranged for the work to be carried and will pass the charges associated with this to the owner.

Two Notices were served on the occupiers of a property on Wollaton Avenue, Gedling on 1<sup>st</sup> February 2013 to prevent noise from a number of dogs barking.

#### Local Government Miscellaneous Provisions Act 1982 Section29

A Notice was served on the owner of a property on Rolleston Drive, Arnold on 20<sup>th</sup> February 2013 to secure the property against unauthorised entry.

#### Environmental Protection Act 1990 sections 87 and 88

Under the above legislation it is an offence if any person throws down, drops or otherwise deposits litter on any public land. The Act also enables the local Authority to operate a fixed penalty scheme whereby the offender may be given the option for paying a fixed penalty within 14 days and so discharge any liability of conviction for that offence by the Court. The current level of fixed penalty is £50.00.

### Information for members

### Fly tipping Section 33 EPA 1990

Fly tipping is the act of depositing waste in or on any land that does not have a Waste Management license that permits the deposit. The definition of waste is simply any substance or object that the holder discards (Throwing away waste on land that doesn't have a permit or permission)

# Duty of Care Section 34 EPA 1990

Duty of care is a legal duty on anyone who producers or carriers and disposers of waste to ensure that waste is transferred only to an authorised person such as a local authority, a registered carrier or a licensed disposer. (Residents must ensure that if they pass waste onto anyone (with or without payment) they must ensure that they check for a waste carriers license to comply with there duty)
