

## **Notices Served – Public Protection**

### **Local Government (Miscellaneous Provisions) Act 1976 s.35**

1. Notices were served on 8 properties on Sidlaw Rise, Bestwood on 1<sup>st</sup> December 2009 for the clearance of a blocked private sewer. The work was carried out in default and the cost will be met by the Council.
2. Notices were served on 13 properties on County Road, Gedling on 10<sup>th</sup> December 2009 for the clearance of a blocked private sewer. The work was carried out in default and the cost will be met by the Council.

### **Local Government (Miscellaneous Provisions) Act 1982 s.29**

1. A notice was served on an empty property on Augustine Gardens, Bestwood on 24<sup>th</sup> November 2009 to secure the building against unauthorised entry. The work was carried out in default and the cost will be recovered from the owner.
2. A notice was served on an empty property on Wollaton Avenue, Gedling on 15<sup>th</sup> December 2009 to secure the building against unauthorised entry. The work was carried out in default and the cost will be recovered from the owner.

### **Environmental Protection Act 1990 Section 80**

1. A notice was served on a property on Worrall Avenue, Arnold on 20<sup>th</sup> November 2009, to clear away and properly dispose of all accumulations of dog faeces and thereafter regularly clear and dispose of all dog faeces so as to prevent the reoccurrence of the nuisance. The notice has been complied with and there have been no further complaints.
2. A notice was served on a Property Company in Nottingham on 20<sup>th</sup> November 2009 to clear away and properly dispose of the accumulation of waste from land at Manvers Street, Netherfield. The site was checked on 21<sup>st</sup> December and it had not been cleared. Further investigations are being carried out.
3. A notice was served on a the owner of Land, Front Street, Arnold on 14<sup>th</sup> December 2009, to cease clear away and property dispose of the accumulation of waste from the land. The notice has not yet expired.

### **Housing Act 2004 Section 239**

1. A notice was served on the landlord of a property on Hilton Road, Mapperley on 4<sup>th</sup> December 2009 in order to enter the premises to survey the property. The Council is liaising with the landlord with regard to further works.

## **Environmental Protection Act 1990 sections 87 and 88**

Under the above legislation it is an offence if any person throws down, drops or otherwise deposits litter on any public land. The Act also enables the local Authority to operate a fixed penalty scheme whereby the offender may be given the option for paying a fixed penalty within 14 days and so discharge any liability of conviction for that offence by the Court. The current level of fixed penalty is £50.00.
