1. Purpose of the Report

To advise the JCSC of the current sickness absence situation.

2. Background

Members will recall that in January 2007, following consultation, the sickness management procedure was changed in response to an increasing level of sickness.


Appendix A shows the current trends in sickness absence over the past two years. The level of absence at the end of 2006/07 showed a decrease over previous years, at 10.16 days lost per employee. However the trend for this year has shown an increase, and at the end of September 2007 the days lost is 12.01 per employee.

It is hoped that by the end of the year this will decrease, since there is a peak in absence over the summer of 2007, and the time lost for the month of September is at a lower level than the previous five months.

Senior Management Team are conscious of the need to actively manage absence, and a more streamlined means of informing managers of employees who reach the trigger points is being implemented. Those who have had no absence for the first 6 months of this year will be receiving their additional half days' leave shortly, and those who had no sickness during the last quarter will be entered into the draw for a prize of £50.

3. Recommendation

It is recommended that the current sickness absence levels are noted.
