licence, he also has delegated authority to decide on the term of the licence (where the application is for 3 or 5 years).

### **Report to Environment and Licensing Committee**

### 1. Notices served under the Environmental Protection Act 1990, Section 80

Following complaints from members of the public and visits from the Police, a notice was served on the owner of a property on Oxengate, Arnold on 25<sup>th</sup> June 2015 regarding loud amplified music. The owner is required to prevent or stop the playing of music, the use of stereo equipment, television or any other electrical equipment capable of amplifying sound at such a volume as to cause a statutory noise nuisance to surrounding properties. The investigations is on-going.

### 2. Notices Served under the Housing Act 2004, Sections 8, 11, 28 and 29 (Hazard Awareness and Improvement Notices)

Following a number of inspections, notices were served on the owner of a property on The Beeches, Carlton on 3<sup>rd</sup> July 2015 relating to the insecure nature of the property, fire safety issues, pest control issues and structural repair. These notices have not been complied with and some of the works will be carried out in default.

### 3. Notices Served under the Local Government (Miscellaneous Provisions) Act 1982, Section 29

Following a visit to the property on 29<sup>th</sup> July 2015 regarding the safety and security of the building, a notice was served on the owner of a property on Burton Road, Carlton on 29<sup>th</sup> July 2015 to secure all entry points into the building so as to prevent unauthorised access into it. The work was carried out and the notice complied with.

A notice was served on the owner of a property on Kelham Mews, Carlton on 5<sup>th</sup> August 2015 to secure entry to the garage so as to prevent unauthorised access. The notice has not been complied with and works will be carried out in default.

### 4. Notices Served under the Food Safety and Hygiene (England) Regulations 2013 – Regulation 6 – Hygiene Improvement Notice

Following a routine food hygiene inspection on 9<sup>th</sup> June 2015, 2 notices were served on the owner of a business on Mansfield Road, Daybrook on 25<sup>th</sup> June 2015 relating to the lack of a documented food management system in operation, inadequate food hygiene training and the poor food hygiene and safety practices that are in place. Compliance of these notices is being monitored.

### 5. Notices Served under the Prevention of Damage by Pests Act 1949, Section 4

Following a visit to the property on 29<sup>th</sup> June 2015, a notice was served on the owner of a property on The Beeches, Carlton on 3<sup>rd</sup> July 2015 to carry out works to keep the property and land free from rats and mice. The notice has not been complied with and officers are now in the process of carrying out works in default of the notice. In this instance the owner will be charged for all works carried out by the Council.

Following discussions, a notice was served on the owner of a property on Kelham Mews, Carlton on 5<sup>th</sup> August 2015 requesting that all domestic refuse, furniture and other waste is cleared away from the garage and disposed of in an authorised manner. This notice has not been complied with and works will be carried out in default.

### 6. Notices Served under the Environmental Protection Act 1990, Sections 87 and 88

Under the above legislation it is an offence if any person throws down, drops or otherwise deposits litter on any public land. The Act also enables the local Authority to operate a fixed penalty scheme whereby the offender may be given the option for paying a fixed penalty within 14 days and so discharge any liability of conviction for that offence by the Court. The current level of fixed penalty is £50.00.

### 7. Duty of Care Section 34 EPA 1990

Duty of care is a legal duty on anyone who imports, produces, carries, keeps or disposes of controlled waste, to ensure that waste is transferred only to an authorised person such as a local authority, a registered carrier or a licensed disposer. (Residents must ensure that if they pass waste onto anyone (with or without payment) they must ensure that they check for a waste carrier's license to comply with their duty.)

The following case under the above legislation was recorded.

A resident of College Road, Mapperley received a caution on 28<sup>th</sup> July 2015 in relation to a Duty of Care offence.
