#### **Purpose of Report**

To approve a proposed increase to gambling fees for 2020/21, as shown in Appendix 2. The current fees for 2019/20 are at Appendix 1.

#### Information

The fixing of fees proposed in the attached fee schedules at Appendix 2 for 2020/21 is a function of the Licensing Act Committee as laid out in The Gambling (Premises Licence Fees)(England and Wales) Regulations 2007. The proposed fees and charges for 2020/21 are designed to ensure that the service operates on a full cost recovery basis.

#### **Proposal**

It is proposed that the fees and charges detailed in Appendix 2 for 2020/21 be approved for implementation from 1 April 2020. There are increases over the fees charged for 2019/20 shown at Appendix 1 and these are to cover extra costs from inflation and additional administration required to ensure a high quality decision making process.

#### **Financial implications**

The proposed fees and charges are designed to ensure that the service operates on a full cost recovery basis.
