Purpose

To approve a proposed increase to gambling fees for 2021/22, as shown in Appendix 2. The current fees for 2020/21 are at Appendix 1.

Recommendation(s)

THAT:

- 1) Members approve the fees and charges detailed in Appendix 2 for 2021/22 to come into effect from 1 April 2021.**

1 Background

- 1.1 The fixing of fees proposed in the attached fee schedules at Appendix 2 for 2021/22 is a function of the Licensing Act Committee as laid out in The Gambling (Premises Licence Fees)(England and Wales) Regulations 2007. The proposed fees and charges for 2021/22 are designed to ensure that the service operates on a full cost recovery basis.

2 Proposal

- 2.1 It is proposed that the fees and charges detailed in Appendix 2 for 2021/22 be approved for implementation from 1 April 2021. There are increases over the fees charged for 2020/21 shown at Appendix 1 and these are to cover extra costs from inflation and additional administration required to ensure a high quality decision making process.
