Subject: Notices Served

### 1. Notices served under the Environmental Protection Act 1990 Section 80

Following complaints from members of the public regarding garden bonfires, a Notice was served on the owner of a property on Ethel Avenue, Mapperley on 30<sup>th</sup> July 2013, to prevent the occurrence of any nuisance from smoke. No further complaints have been received regarding this property.

Following complaints from members of the public regarding loud music, a Notice was served on the owner of a licensed premises on Cavendish Road, Carlton on 25<sup>th</sup> September 2013, to cease the playing of loud music at such a volume as to cause a statutory noise nuisance. Environmental Health Officers are continuing to monitor compliance with this notice.

### 2. Notices Served under the Public Health Act 1936 Section 79

Following complaint from members of the public regarding rubbish to the rear of a property, a notice was served on the owner of a property on Carlton Hill, Carlton on 9<sup>th</sup> August 2013 to clear the property of accumulations. This notice has been complied with.

# 3. Notices Served under the Health and Safety at Work Etc Act 1974 Sections 21, 23 & 24

A notice was served on the owner of a premises on Hallams Lane, Arnold on 29<sup>th</sup> July 2013 to clean or replace couches/seats in the premises which were in poor condition which may have led to exposure of clients to blood-borne biological agents including Human Immunodeficiency Virus (HIV) and hepatitis viruses. This notice has been complied with.

## 4. Notices Served under the Food Hygiene (England) Regulations 2006- Regulation 6

2 Food Hygiene Improvement notices were served on a premises on Main Street, Burton Joyce on 11<sup>th</sup> September 2013. The premises was awarded a 1 rating under the Food Hygiene Ratings Scheme. This premises will be monitored for compliance with these notices.

12 Food Hygiene Improvement notices were served on a premises in Burntstump Country Park on 12<sup>th</sup> July 2013. The premises was awarded a 0 rating under the Food Hygiene Ratings Scheme. These notices have now been complied with and the premises has since been re-rated

with a rating of 3. We will continue to monitor standards at this establishment.

- 2 Food Hygiene Improvement notices were served on a premises on Westdale Lane, Mapperley on 17<sup>th</sup> September 2013. The premises was awarded a 1 rating under the Food Hygiene Ratings Scheme. This premises will be monitored for compliance with these notices.
- 2 Food Hygiene Improvement notices were served on a premises on Carlton Hill, Carlton on 30<sup>th</sup> August 2013. The premises was awarded a 1 rating under the Food Hygiene Ratings Scheme. This premises will be monitored for compliance with these notices.
- 5 Food Hygiene Improvement notices were served on a premises on Carlton Square, Carlton on 17<sup>th</sup> September 2013. The premises was awarded a 2 rating under the Food Hygiene Ratings Scheme. This premises will be monitored for compliance with these notices.

# 5. Notices Served under the Housing Act 2004 Section 16

A Revocation of Prohibition Order was served on the owner of a property on Furlong Avenue, Arnold on 4<sup>th</sup> September 2013 for completion of works in relation to a Prohibition Order dated 3<sup>rd</sup> March 2011.

#### 6. Notices Served under the Environmental Protection Act 1990 Sections 87 and 88

Under the above legislation it is an offence if any person throws down, drops or otherwise deposits litter on any public land. The Act also enables the local Authority to operate a fixed penalty scheme whereby the offender may be given the option for paying a fixed penalty within 14 days and so discharge any liability of conviction for that offence by the Court. The current level of fixed penalty is £50.00.

# **Duty of Care Section 34 EPA 1990**

Duty of care is a legal duty on anyone who imports, produces, carries, keeps or disposes of controlled waste, to ensure that waste is transferred only to an authorised person such as a local authority, a registered carrier or a licensed disposer. (Residents must ensure that if they pass waste onto anyone (with or without payment) they must ensure that they check for a waste carrier's license to comply with their duty)
