We write on behalf of our client, Ibstock Building Products Ltd to unfortunately inform you of temporary closures to parts of their Dorket Head Brickworks with effect from 22 December 2017. The closure has affected the main production/manufacturing area of the factory hatched green on the attached plan and the associated stock yard and offices highlighted yellow on the attached plan.

The closure was due to essential repairs to ensure continual brick production at the factory. The factory is due to come back on line; recommencing production on the 12<sup>th</sup> January 2018, during this downtime up until 2<sup>nd</sup> January 2018 there was no brick dispatching whatsoever from the site and the offices were temporarily closed as a result of the repair works.

I attach a plan identifying the temporary vacated areas during the period 22 December 2017 to 12 January 2018. The areas highlighted and hatched green are exclusively off line from 23 December 2017 until 12 January 2018 (23/12/17 – 12/01/18). The areas highlighted yellow were exclusively offline from 22 December 2017 until the 2 January 2018 when brick dispatching resumed (22/12/2017 – 02/01/2018).


On the above basis please could you grant Section 44A Relief on the unoccupied parts of the works for the above temporary period.
