Subject: Christmas and New Year Opening for Leisure Facilities 2021/22

Purpose

To seek approval for opening hours for the Council's leisure facilities over the Christmas and New Year holiday period 2021/22.

Recommendation

THAT:

1) Approval is given to the opening hours for the Council's leisure facilities over the Christmas and New Year holiday period 2021/22, as set out in appendix 1 to this report.

1 Background

- 1.1 Previously, reports have shown relatively poor income and attendances over the Christmas and New Year Period as most regular and block booking customers do not attend. Generally usage is low which is why leisure centres reduce their normal opening hours around the bank holidays.
- 1.2 By operating a reduced service over this period it allows staff to take annual leave where required, without providing full replacement cover. It

- therefore seems sensible in both operational and business terms to reduce the opening hours.
- 1.3 The opening times at Arnold, Calverton, Carlton Forum and Redhill have been reviewed holistically in order to offer customers access to the full range of leisure activities on a reduced opening basis. Opening later in to the evening from 27th 30th December has always proved unpopular and therefore a daytime-only operation is proposed.
- 1.4 Over the past two years, opening Carlton Forum until 3pm on Christmas Eve and New Year's Eve proved successful and it is proposed to continue this in 2021.
- 1.5 The Richard Herrod bars and the Bonington Bar were closed due to the tier 3 restrictions in place in 2020/21.
- 1.6 There is maintenance works planned by Col. Frank Seeley School on 22nd and 23rd December, which will leave the site without power and therefore unable to open.
- 1.7 The pool filter medias at both Calverton and Carlton Forum are being replaced from Monday 20th December. This means that these sites will be without swimming pool facilities from Monday 20th up until Saturday 1st January. The pools will reopen as of Sunday 2nd January.

2 Proposal

It is proposed that:-

2.1 The Christmas and New Year opening hours of the leisure facilities, as shown in appendix 1, are authorised.

3 Alternative Options

- 3.1 The council could do nothing and continue to open the leisure facilities with the normal operating hours. This option would mean a waste of resource in terms of heating, lighting and staffing of the facilities for extremely low levels of customer use.
- 3.2 Alternative opening hours to those contained in the proposal could be considered. However the proposal takes into account previous year's usage levels and customer feedback of wanting to access facilities from 6.30am until the evening.

3.3 The Richard Herrod Centre could be opened on Boxing Day. However, usage has traditionally been very low on this day and the cost of opening on this day is approximately £650 more than if the centre was closed, which is down to additional staffing costs.

4 Financial Implications

- 4.1 The proposed closure days are in accordance with a schedule previously agreed with the unions. However, for the reduced hours staff will be expected to take this time as annual leave or lieu time.
- 4.2 Following consultation with employees at the centres, all sites can be adequately staffed on the days and at the times proposed for opening. Where appropriate, employees agreeing to work on agreed closure days will have appropriate rates of pay applied to them.
- 4.3 The proposed opening and closure dates are consistent with the approved base budget.

5 Legal Implications

There are no legal implications associated with the revision to the opening hours.

10 Reasons for Recommendations

- 10.1 To allow for a reduced provision in customer service at the Council's leisure facilities over the Christmas and New Year period, as has happened in previous years. This is based on customer usage and feedback from previous years.
- 10.2 To allow staff to take annual leave without the need to provide cover.
- 10.3 To ensure that the centres are operating within the approved base budget.
