The proposal is to install one Bosch Auto Dome IP starlight 7000i 30X Pendent Clear 1080p camera mounted on a new CCTV column in Burton Joyce.

The camera will transmit via a fibre optic connection provided by Gedling Borough Councils preferred contractor to the CCTV control room where it can connect into the existing network. It will then be interfaced with the existing control equipment.
