The main objective of the market consultation.	<p>To permanently relocate the Arnold Market to Eagle Square, subject to planning.</p> <p>The consultation process has surveyed retailers, traders and shoppers, through face to face and online surveys. The consultation provided an opportunity to include questions within the Ambition Arnold benchmarking. These questions were specifically market centric extending the reach of the survey and data collected.</p> <p>The market consultation was undertaken between 7/10/24 and 31/10/24. Whilst the Ambition Arnold survey and bench marking were undertaken during the summer 2024. The findings of all of the surveys support the recommendations included in the Arnold Market Report that include a proposal to review the policies and operating model of market provision which will include consideration of environmental factors such as waste, single use plastic, seasonal and sustainable markets, etc.</p>
